Yuma's Education Scholarship Fund for Kids, Inc. (**Yes!** Fund for Kids) is a School Tuition Organization in accordance with the provisions of A.R.S. 43-1089. It was incorporated in 2003 for the purpose of implementing the Arizona Private School Tuition Tax Credit and is a tax-exempt charitable organization pursuant to section 501C(3) of the Internal Revenue Code.

How The Tax Credit Program Works For Kids

The Arizona Private School Tuition Tax Credit law, A.R.S. Section 43-1089, allows Arizona taxpayers to make donations each year to Yuma's Education Scholarship Fund for Kids, Inc. (**Yes!** Fund for Kids).

A married couple filing jointly can make a donation up to \$1,000 and a single taxpayer's donation can be up to \$500. The taxpayer will receive a dollar-for-dollar tax credit against their Arizona state income tax. If the taxpayer has actual Arizona state income tax less than the allowable credit, the law allows a carryover of any unused donation for up to five years.

A taxpayer may also be able to claim a federal deduction for the donation. The taxpayer should consult their tax advisor for specific tax advice.

The **Yes!** Fund for Kids is dedicated to increasing the opportunities for children to receive a Christian education through the efficient implementation of the provisions of the Arizona Private School Tuition Tax Credit.

What You Can Do

- ☺ Complete a **Yes!** Donation Card and send a check for up to \$1,000 to the Yuma Education Scholarship Fund for Kids, Inc. (**Yes!** Fund for Kids). The address is 3234 South Appaloosa Way, Yuma, AZ 85365. Donations must be postmarked by December 31 to be claimed as a credit for the year.
- ☺ You will receive a receipt by January 31 of the year following the tax year that your donation was made.
- ☺ Complete forms 301 and 323 and attach to your Arizona state income tax return.
- ☺ You can also receive the tax credit for the public school extra-curricular activities donation of \$250 (for married taxpayers) or \$200 (for a single taxpayer).

At least ninety percent of the donated funds received will be used to tuition grant/scholarships. Admission decisions are the exclusive responsibility of the school. The maximum Arizona state income tax credit is \$1,000 for married persons filing jointly or \$500 for a single taxpayer, or the actual tax, whichever is less. These donations are pursuant to A.R.S. Section 43-1089. Donations must be postmarked or delivered to the organization by December 31 to be claimed as a credit for the year.
